

This is a synopsis of the events:

1. On November 24th, National-Justice (NJP, [REDACTED]) glued flyers to downtown planters. The fliers headline was "THEY WANT WHITE PEOPLE DEAD!" NJP is a WSEO.
2. On November 24th- 25th, we received a phone call from an out of state individual that claimed to be coordinating a contingent of Oathkeeper to come to Waukesha on Monday November 29th. Oathkeepers is described by the FBI as a "paramilitary organization... that is a large but loosely organized collection of militias who believe the federal government has been corrupted.." The caller stated that BLM had declared war on white people and that is why they were coming to Waukesha and Milwaukee. In discussions with the caller, he agreed to advocate against coming, but said he was not the final say. We worked with the Southeast WI Threat Analysis Center (STAC) to determine the level of threat this posed. [REDACTED]

3. On November 27th, a group of NJP protestors showed up at the Waukesha County Courthouse. STAC indicates that NJP has previously only drawn 100 people to a rally, however, there is the possibility for them or other WSEO to mobilize Wisconsin Based WSEO – Patriot Front/The Base/ New World Order (Milwaukee). NJP has affiliation with the individuals that helped to organize the "Unite the Right" rally in Charlottesville, Virginia in 2017. The protestors did not create problems. See photo of activity.
4. On November 28th, Officer N. Smidt discovered a Twitter post regarding the Proud Boys planning to come to Waukesha on December 18th to march the parade route. This information was forwarded to STAC so they can assist us in determine whether it will materialize and potential for violence.
